Q. What are the eligibility requirements?

A: Candidates must be part- or full-time U.S. Bath & Body Works associates who are employed as of the application deadline, their dependent children, or their spouses.

- Dependent Children: includes biological children, legally adopted children, stepchildren, and any children for whom you are the legal guardian.
- Spouse: includes the person to whom the employee is legally married.
- Candidates must be graduating high school seniors, graduates who are pursuing a two- or four-year college or university, or an industry-based career or technical program.
- Candidates must attend an accredited program in the U.S.

Q. How do I apply?

- Application Information
 - o To include employee/relationship to employee information.
- Essay: Use the phrase "Passion Leads to Success" as a prompt to describe how you have applied or might apply this concept to your life. 500 – 1,000 words.

Resume: include school, work, extracurricular, volunteer, etc. experience.

- Two Letters of Recommendation: can be academic, work, volunteering, etc.
- FAFSA Submission Summary.

The Columbus Foundation will share candidate information with contacts at Bath & Body Works (BBW). Should you receive the scholarship, you will be asked would you be comfortable with the BBW team contacting you about sharing the good news.





Q. When is the deadline?

A: August 1, 2024.

Q. What is the selection criteria?

A:

- 50% Belief that Passion Leads to Success. Determined through essay.
- 20% Financial Need.
- 15% Commitment to Completion of Educational Program.
- 15% Community Engagement.

Q. Who is on the selection committee?

A: Selection committee is comprised of appointees of the Columbus Foundation.

Q. What is the award amount?

A: 20 scholarships for \$10,000 payable over two years at \$5,000 per year.

Q. How is the scholarship renewed?

A: The scholarship is renewable for one year; however, the recipient must provide proof for enrollment for the second year.

• The Columbus Foundation will send an email with a link to provide this proof.

Q. What is the payment distribution?

A: All awards are paid directly to the educational institution & the scholarship funds can be used for any educational expenses.

Q. What is the process the Columbus Foundation uses for this scholarship opportunity?

A:

- The Columbus Foundation prepares the application.
- Bath & Body Works (BBW) publicizes the scholarships availability to associates.
- Candidates complete the online application by the deadline.
- After the deadline, The Columbus Foundation reviews complete applications for eligibility.
- The Columbus Foundation sends a spreadsheet to HR at BBW that includes the applicant information and the employee information for confirmation of eligibility.
- The Foundation sets up the online review.





- After selection, the Foundation notifies BBW of the recipient information to confirm the notification process for those who received the scholarship. This process can take up to 2 months.
- The Foundation notifies those who did not receive the scholarship by email.
- The Foundation sends award letters to recipients that explain the payment request process and include the proof of enrollment form.
- Once proof of enrollment has been received by the Foundation, a check will be sent to the recipient's educational institution.
